John Baines

John Baines is directing his 15th Skills Camp over the past 18 years. He, along with former Elmhurst head coach Mark Scherer, created this camp in 2001.

Baines began his collegiate coaching career at Elmhurst in 2000-01. Baines has been named the Illinois Basketball Coaches Association

(IBCA) coach of the year as recently as 2015. He has been coaching collegiate basketball for 18 years and owns the best winning percentage as a head coach at both University of St. Francis (2011-2013) and Elmhurst College (present) in both school's history. He has guided the Bluejays to 2 trips to the NCAA tournament and has won a game in both appearances.

Baines is a math education major from Illinois Wesleyan and has a Master's degree from Virginia Commonwealth in the area of Sports Management. Baines is married to wife, Emily, and has two children, Sloane and Jackson. They reside in Addison, IL.



Peyton Wyatt

Peyton Wyatt will be entering his first year as an assistant men's basketball coach and head men's golf coach at Elmhurst College. Wyatt most recently served as a graduate assistant for the men's basketball team at Elmhurst College. As a veteran of the Basketball Skills Camp, Wyatt will be leading his 7th season at camp.

Wyatt spent his basketball playing career at Elmhurst College reaching the round of 32 in the NCAA Division III tournament his junior and senior year. Wyatt is currently ranked second all-time at Elmhurst College for three-point field goal percentage at 42.8. In his junior year, he topped the College Conference of Illinois and Wisconsin (CCIW) in three-point percentage with a mark of 47.4%. He graduated from Newton Community High School in Newton, Ill. in 2008 where he is the all-time leading scorer and an IBCA All-State selection his junior and senior years in basketball.

Wyatt has a bachelor's degree in Elementary Education and a Master's degree in Business Administration at Elmhurst College.



Emily Baines

Emily is working her 4th Skills Camp over the past 5 years. Emily played college basketball at UNC-Charlotte and has her Master's degree in Sport Management. Emily has coached at the collegiate level at VCU and Wagner University, as well as being a head girl's high school coach at Gar Field High School in

Woodbridge, VA. Emily was a K-8 physical education teacher for 8 years and specializes in youth basketball. Emily is the wife of Director, John Baines, and has two children, Sloane (3) and Jackson (1).
